

**ORDINANCE NO. 2007-05
CITY OF HIGHLAND, ARKANSAS**

**AN ORDINANCE TO AMEND ORDINANCE NO. 2007-01 FIXING
RATES FOR INSTALLATION OF SEWER PUMPS, TANKS AND
SERVICE LINES AND REQUIRED CONNECTIONS TO THE SEWER
SYSTEM FACILITIES AND RE-CONNECTION FEES AND DECLARING
AN EMERGENCY TO EXIST**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HIGHLAND,
ARKANSAS:

Section 1: A new Section 2 (c) is added to Ordinance No. 2007-01, to wit:

(c) Payment of connection fees shall be made as follows:

(i) If the City performs the work under Section 2 (a), the fee may be paid as follows: **(1)** a minimum of \$1,500.00 (one thousand five hundred dollars) at the time of request for the work to be performed and the balance paid upon the completion of the installation or **(2)** paid in full at the time of request.

(ii) If the owner elects to perform the work under Section 2 (b), the fee shall be paid in full at the time of purchase of the pump and equipment.


Section 2: Emergency Clause. This Ordinance being necessary for the preservation of the public peace, health, comfort, convenience, morals, safety, and welfare of the City of Highland, Arkansas, an emergency is declared to exist and this Ordinance shall be in full force and effect from the date of its adoption.

**AN ORDINANCE TO AMEND ORDINANCE NO. 2007-01
FIXING RATES FOR INSTALLATION OF SEWER
PUMPS, TANKS AND SERVICE LINES AND REQUIRED
CONNECTIONS TO THE SEWER SYSTEM FACILITIES
AND RE-CONNECTION FEES AND DECLARING AN
EMERGENCY TO EXIST**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
HIGHLAND, ARKANSAS:

Section 1: A new Section 2 (c) is added to Ordinance No.
2007-01, to wit:

(c) Payment of connection fees shall be made as follows:

(i) If the City performs the work under Section 2 (a),
the fee may be paid as follows: **(1)** a minimum of \$1,500.00 (one
thousand five hundred dollars) at the time of request for the work
to be performed and the balance paid upon the completion of the
installation or **(2)** paid in full at the time of request.

(ii) If the owner elects to perform the work under
Section 2 (b), the fee shall be paid in full at the time of purchase
of the pump and equipment.

Section 2: Emergency Clause. This Ordinance being
necessary for the preservation of the public peace, health,
comfort, convenience, morals, safety, and welfare of the City of
Highland, Arkansas, an emergency is declared to exist and this
Ordinance shall be in full force and effect from the date of its
adoption.
